Outside booths must supply their own tents, tables, and chairs. Vendors may purchase multiple booths if they wish; however, there is no discount for additional booths purchased.

- 10 x 10 booths inside the Longview Exhibit Building are \$25 each (includes one table, two chairs).
• 10 x 10 booths outside the Longview Exhibit Building are \$15 each (must provide own table, chairs, tent).
• 10 x 10 booths for Non-Profit groups are free (Certification must be provided and received with application).
• Food Vendor fees are \$150 for profit and non-profit groups (HEALTH DEPT. PERMIT and INSURANCE MANDATORY).

• Vendor set-up is 2:00 p.m.–8:00 p.m. on Wednesday, July 3rd, and 7:30 a.m.–10:30 a.m.* on Thursday, July 4th.

• Vendor tear-down is 8:00 p.m. – midnight on Thursday, July 4th.
• Vendors are responsible for Sales Tax ID numbers and reporting sales. Please provide your # below.
• Festival admission and Fireworks Show are free to the public. Prices vary for individual activities.
• Festival hours are 11:00 a.m. – 9:30 p.m. Fireworks are 9:30 p.m. – 10:00 p.m.
